We are hosting this event with Radius Church/Frazer Dream Center since many of the families we will be helping are affiliated with the Frazer Dream Center.

The projects for the weekend include small construction projects, painting, demolition, yard work, and a small "sports camp" for the kids. The students will be divided into work groups (8 students per work group) made up of boys and girls from different grades and churches. An adult leader will be assigned to each work group. All of the work sites are within walking distance of Radius Church/Frazer Dream Center.

Non-Negotiable

1. I will not bring or use alcohol, illegal drugs or tobacco products of any kind.

Expectations

1. I will be present for the entire event and participate fully in all scheduled activities.
2. I will not leave the event site and make sure an adult leader knows where I am at all times.
